# 2024-2025 Schedule of Payments and Fees

## • Tuition 4 yr. old (K-4):

- \* \$1,500.00 annually or \$150.00 monthly for ten months. (Half Day Program 8:30 a.m. to 12:00 p.m.)
- \* \$3,000.00 annually or \$300.00 monthly for ten months. (Full Day Program 8:30 a.m. to 3:00 p.m.)
  - As a rule, K4 students should have reached the age of 4 by September 1<sup>st</sup>.
  - $\circ$   $\,$  Some exceptions are possible with the approval of the Administration.
  - K4 Full Day Program includes Aftercare as needed.

### • Tuition (K-5 through 12<sup>th</sup>):

- \* K-5 through eighth grade \$610.00 monthly for ten months.
- \* Ninth through twelfth grade \$635.00 monthly for ten months.

### • <u>Discounts</u>:

\* Faith Baptist Church offers some private scholarship opportunities to self-pay families.

• **Before/After Care Times and Fees:** (Multi-Child Discount available, must be paid in advance of the month, not funded by scholarships, non-refundable)

### • <u>Fees</u>:

- \* \$325.00 New Student Fee (non-refundable and required, in full upon enrollment, not funded by scholarship)
- \* \$250.00 K4 Book Fee (non-refundable)
- \* \$425.00 K5-12<sup>th</sup> Book Fee (non-refundable)
- \* \$300.00 Uniform Fee (non-refundable)
- \* \$100 SAT Fee (non-refundable)
- \* \$50.00 Media Fee (non-refundable)
- \* \$3.50 PACE Fee (for paces after a student completes 75 paces in a school year) (per pace price, non-refundable, not funded by scholarships)
- \* \$5.00 Failed Test Fee (non-refundable, not funded by scholarships, applies to A.C.E. students)
- \* \$40.00 Graduation Fee (K5 & 12<sup>th</sup> grade graduates only non-refundable)
- \* Academic Support (small group setting, non-refundable)
  - \$25.00 per hour
  - o \$3,000 annually
    - Scholarship funds from FES-UA <u>up to</u> \$3,000 above tuition and applicable fees may be used for Academic Support.
    - FTC & FES-EO scholarships do not cover Academic Support fees.
    - Academic Support requires meeting with administration for scheduling purposes.

#### Payment Process:

All payments are due on the first of the month. Payments are considered past due on the 10<sup>th</sup> of the month and a late fee may be applied. The normal payment schedule is from August 1<sup>st</sup> through May 1<sup>st</sup>. If a student is withdrawn prior to the last day of the month, one full month's tuition will be NON-REFUNDABLE. All fees are non-refundable. If the student is a scholarship recipient, unpaid monies will be the sole responsibility of the parent/guardian and will be <u>due immediately</u>. All tuition and fees for a current school year must be current prior to re-enrolling for the following year. Faith Christian Academy reserves the right to withhold services such as, but not limited to, class attendance, tutoring, participation in events including awards ceremonies and graduation, and Before and After Care if accounts are not kept current. Fees are for the use of items and do not constitute ownership of items. Faith Christian Academy retains ownership of all materials and all materials are to be used by currently enrolled students only. All scholarship families are ultimately responsible for their child's fees and tuition and will be required to pay any amount not covered by a scholarship. **Delinquent accounts forfeit all discounts**. No records will be transferred until any outstanding balance is paid in full.
